CO-OP COMMUNITY CHAMPION- We are a Lincolnshire Co-op

Community Champion, so you can generate a donation to the park each time you shop without affecting your own dividend points in any way.

All you have to do is select us online or take your dividend card to the pool office when we're open and we'll help you do it manually.

To do it online go to <http://www.lincolnshire.coop/community/community-champions/> , sign into your account by clicking 'membership' at the top of the page and then 'log into my account'. To sign into your account or register all you need is your dividend card number.

Once logged in a welcome screen comes up with 4 bullet points. The 4th point is 'change community champion preference.' Click on this. Find Jubilee Park Woodhall Spa on the drop down list and press search, it will then allow you to select the park. All done!

Charity Gift Aid Declaration – single donation

Boost your donation by 25p of Gift Aid for every £1 you donate
